- details about the institution organizing the doctoral studies (number of Doctoral Schools, number of students, institutional context, short history etc.);

Established in 1919, the National Academy of Music "Gheorghe Dima" is a state institution of higher education and research and includes the following forms of education: undergraduate studies, master's studies and doctoral studies. The institution is located in the historical capital of Transylvania, Cluj Napoca, a city where there was, since 1581, a Jesuit College, the first higher education institution established in the current territory of Romania. Multicultural and multidenominational municipality with an active population of over 400,000 inhabitants, Cluj-Napoca is a university center with 12 state and private universities that enrolls over 80,000 student.

Since 1990, the institution received the name The Music Academy "Gheorghe Dima" and the awarding of the title of Doctor Honoris Causa was established. During this period, the Academy of Music operates with three faculties: the Theoretical Faculty, the Faculty of Musical Interpretation and the Faculty of Performing Arts.

Under the patronage of the "Gheorghe Dima" Academy of Music from Cluj-Napoca, in 1998 the Music College from Piatra Neamţ was established (with short-term studies - 3 years, full-time courses), which became in the academic year 2005-2006 the fourth faculty of the Cluj institution. Starting with the academic year 2012 - 2013, the Faculty of Music from Piatra Neamţ becomes a University Extension of the Academy of Music "Gh. Dima".

In 2012 changes were made to the organizational structures of MAGD, wanting to optimize the mechanisms to promote quality at all levels of activity, as follows: two faculties (instead of four, the

Faculty of Performing Arts being included in the Faculty of Music Performance, and the Piatra Neamţ Faculty of Music operating as an extension of three undergraduate programs of MAGD Cluj-Napoca) and seven departments (instead of eleven).

In the National Academy of Music "Gheorghe Dima" there are 1223 students (58 foreign students, 66 PhD students) and 204 members of teaching staff (124 tenures, 54 associated and 26 in the Doctoral School).

The structure of the NAMGD

Stylistics of musical performance - conducted;

Stylistics of musical performance - instrumental performance;

Stylistics of musical performance - vocal performance;

The arts of musical performance - choreographic direction, musical theater direction.

Domain A. INSTITUTIONAL CAPACITY

Criterion A.1. The administrative, managerial institutional structures and the financial resources

Standard A.1.1. The institution organizing doctoral studies (IODS) has implemented the efficient functioning mechanisms provided in the specific legislation on the organization of doctoral studies.

Performance Indicator A.1.1.1. The existence of specific regulations and their application at the level of IODS, respectively of the doctoral school, having as reference period the last five years.

- (a) internal regulations of the administrative structures (the institutional regulation for the organization and development of doctoral university studies, the regulations of the doctoral schools);
- (b) the methodology for conducting elections at the CDS level, for doctoral schools and evidence of their conduct;
- c) the methodology for conducting the last competition for the position of CDS director and evidence of its development
- d) methodologies for organizing and conducting doctoral studies (admission of doctoral students, completion of doctoral studies

Performance Indicator A.1.1.2. The regulations of the doctoral school include criteria, procedures and mandatory standards for the aspects specified in art. 17 para. (5) of the Code of doctoral studies, approved by Government Decision no. 681/2011, with subsequent amendments and completions

The doctoral university studies are carried out based on the legislation in force as well as on its own procedures / methodologies / regulations, including all mandatory criteria,

Fulfilled

Performance Indicator*A.1.1.3. The doctoral schools of IODS are organized on disciplinary and interdisciplinary disciplines or topics, in accordance with art. 158 paragraph (7) of the LEN

Within IODS there is only one doctoral school related to the MUSIC field

Standard A.1.2. IODS has the necessary logistical resources to fulfill the mission of doctoral studies.

Performance Indicator A.1.2.1. . Existence and effectiveness of an adequate computer system for the record of doctoral students and their academic background

IODS holds records of all doctoral students within the NAMGD Doctoral School.

The computer records of doctoral students and their academic background are kept in electronic format in Excel and Word documents. The doctoral school has a dedicated, bilingual site, https://anmgd.ro/doctorat/, which has the following structure: the Council for doctoral university studies (CSUD Composition, IOSUD Regulation), the Doctoral School (about the Doctoral School, the Doctoral School Council, Regulations, Doctoral supervisors), Conducting studies (General information, Curriculum, Doctoral studies contract), Admission (Methodologies / Procedures / Regulations, Admission calendar; registration forms, Required documents), Doctoral theses (Public defenses, Documents required, Standards for accepting doctoral theses, Forms), Habilitation, Archive, News

Recommendation:

I would recommend the creation of an alumni observatory, integrating a clear institutional policy on data collection and monitoring of alumni and gathering data of their employment, countries, geographic areas, other sources of data and how many of them are employed on the music labor market.

Fulfilled

Performance Indicator A.1.2.2. Existence and use of a computer program and evidence of its use to verify the percentage of similarity in all doctoral theses.

Starting with 2019, the doctoral theses are evaluated on the *sistemantiplagiat.ro* platform, an IT tool dedicated to comparing documents in text format. The system provides information that allows the identification of the number of loans in the analyzed text, as well as the sources in which they were identified.

The similarity report is sent to the doctoral supervisor who issues a resolution and, depending on the result, the file is forwarded to carry out the next steps of the process of obtaining the doctoral degree.

Criterion A.2. Research infrastructure

Standard A.2.1. IODS / Doctoral schools have a modern research infrastructure that supports the development of activities specific to doctoral studies

Performance Indicator A.2.1.1. IODS / Doctoral school / schools present evidence regarding the possession or rental of spaces for research activities specific to doctoral study programs (laboratories, experimental fields, research stations, etc.

The NAMGD has adequate spaces for teaching, artistic creation and scientific research. Additionally the new headquarters of NAMGD is financed and is in the construction stage. The value of the investment is RON 140,471,442.

Fulfilled

Performance Indicator A.2.1.2. *IODS / The doctoral school (s) has collaboration agreements signed with higher education institutions, research institutes, research networks for the exploitation in partnership of various research infrastructures and publicly presents its offer of research services through a platform profile.*

There is a partnership with the National University of Music in Bucharest -Center for Nineteenth-Century Music Studies, which aims at scientific and educational collaboration.

In 2021, the "Sigismund Toduță" Doctoral School concluded a partnership with the Romanian National Opera Cluj-Napoca, with the participation of the French Institute Cluj-Napoca, in order to realize the symposium OPERA INTERNATIONAL APERTA 2021.

The doctoral school signed a partnership with the Sigismund Toduță Foundation regarding the didactic, artistic and scientific activity.

Fulfilled

Performance Indicator A.2.1.3. *IODS / Doctoral School (s) demonstrates its concern for the permanent renewal of research infrastructure that provides doctoral students with access to current research resources, through application in various competitions for research infrastructure funding and through procurement for research infrastructure. research from IODS's own revenues.*

The members of the doctoral school coordinated 41 grants and projects, amounting to RON 2,459,797. The part of this sum is spend for the permanent renewal of the research / artistic creation infrastructure, which ensures doctoral students access to current research / artistic creation resources.

The following FDI projects had as objective the development of the doctoral school:

2016 project entitled "International Development in Music and Academics"
2019 project entitled "Development of research excellence in MAGD"
2020 project entitled "Consolidation of Excellence in scientific research and artistic creation in NAMGD".

Next three projects of the Doctoral School were submitted in 2021:

Criterion A.3. Quality of human resource

Standard A.3.1. At the level of each doctoral school there are enough qualified staff so as to ensure a quality educational process

Performance Indicator *A.3.1.1. The share of doctoral supervisors who coordinate more than 8 doctoral students at the same time, but not more than 12, during their doctoral studies does not exceed 20%.

The doctoral school does not exceed in the analyzed period the percentage of 20% doctoral supervisors to coordinate at the same time more than 8 doctoral students, but not more than 12, during doctoral studies.

Fulfilled

Performance Indicator A.3.1.2. At least 50% of the teaching / research staff involved in teaching and research activities related to the programs of preparation of advanced university studies or in the individual programs of scientific research or artistic creation are holders of IODS, employed with the conclusion of an employment contract for an indefinite period.

Out of the 12 doctoral supervisors, 9 are tenured at the NAMGD DS.

Domain B. EDUCATIONAL EFFECIENCY

Criterion B.1. Number, quality and diversity of candidates who applied for the admission competition.

Standard B.1.1. Candidates admitted to doctoral studies demonstrate academic, research and professional performance, are diversified as gender and social representation.

Performance Indicator *B.1.1.1. Admission to doctoral study programs is based on selection criteria that include: previous academic, research and professional performance of the candidates, their interest in scientific or artistic / sports research, publications in the field and a proposal for a subject of research. An interview with the applicant is a mandatory part of the admission procedure.

Admission to doctoral studies are made in accordance to Regulation for admission to doctoral university studies and in compliance with the following criteria and standards:

Criteria:

Training and professional skills (scientific and artistic)of the candidates. Transversal skills:-language and communication skills (oral and written); Respecting the values and principles of scientific research ethics.

Standards:

Evaluation of the professional CV,
Written test,
Presentation of the research project.
The dropout rate of doctoral students 2 years after admission is 0

Fulfilled

Performance Indicator B.1.1.2. IODS / Doctoral school / schools have a policy of stimulating the enrollment of doctoral students from disadvantaged social backgrounds, by allocating special places for admission and / or granting social scholarships, as well as organizing support programs to prevent dropout from university.

Candidates with a precarious financial situation are exempted from paying admission fees and can benefit from scholarships, according to the Scholarship Regulations. There were no dropouts due to financial reasons.

Fulfilled

Criterion B.2. The content of doctoral university study programs

Standard B.2.1. The training program based on advanced university studies is appropriate to improve the research skills of doctoral students and to strengthen ethical behavior in science.

Performance Indicator B.2.1.1. The training program based on advanced university studies comprises at least three disciplines relevant for the training in scientific research of doctoral students, of which at least one discipline is intended for the in-depth study of research methodology and / or statistical data processing.

The training program based on advanced university studies aims to improve the research skills of doctoral students and strengthen their ethical behavior.

PhD students have the opportunity to participate in at least two courses in a package of five disciplines, coordinated exclusively by doctoral supervisors:

- 1. The stylistics of the music of the 20th century (acad. Prof. Univ. Dr. Cornel Țăranu)
- 2. Analysis of musical performance (Prof. Univ. Dr. Adriana Bera)
- 3. Methodology and ethics of scientific research (Prof. Dr. Pavel Puşcaş)
- 4. Elaboration of institutional research projects(Prof. Dr. Nelida Nedelcuţ)
- 5. Writing, technical editing and presentation of scientific texts (Prof. Dr. Gabriel Banciu)

Fulfilled

Performance Indicator B.2.1.2. There is at least one discipline dedicated to ethics in scientific research and well-defined intellectual or thematic property on these topics within a discipline taught in the doctoral program.

Ethics in scientific research is a permanent concern of all doctoral supervisors in the activity of guiding doctoral students. Examples of the course may be *Methodology and ethics of scientific research* (Prof. Dr. Pavel Puṣcaṣ). Research ethics is also included in the course of Prof. Univ. dr. Gabriel Banciu (Writing, technical editing and presentation of scientific texts), and is a permanent concern of all doctoral supervisors in the activity of guiding doctoral students.

Fulfilled

Performance Indicator B.2.1.3. IODS has created mechanisms to ensure that the training program based on advanced university studies, related to the evaluated field, aims at "learning outcomes", specifying the knowledge, skills and responsibility and autonomy that PhD students should acquire after completing each discipline or through research activities.

The study programs ensure the conformity between the competencies acquired in higher education and the learning outcomes related to the occupations in the Classification of Occupations in Romania

For the evaluation of the training programs within the advanced university studies, the following means are used:

- -evaluation and approval of the subject sheet within the program;
- -evaluation of doctoral students at the end of the courses;
- -evaluation of the degree of satisfaction of doctoral students (questionnaire and informal discussions).

Recommendation:

Though until now it is not obligatory to have formalized Learning Outcomes (it will be introduced in 2023) I would recommend to have formalized Learning Outcomes for PhD programmes integrating knowledge, skills and social competences, and their descriptions aligned with the Romanian Qualification Framework (for example AEC Learning Outcomes)

I would recommend also that the connection between assessment criteria and learning outcomes be clearly visible.

Fulfilled

Criterion B.3. The results of doctoral studies and their evaluation procedures

Standard B.3.1. The research is capitalized by doctoral students through presentations at scientific conferences, scientific publications, technology transfer, patents, products, service orders

Performance Indicator B.3.1.1. Within the doctoral school there are mechanisms for capitalizing on the results of doctoral studies according to the specifics of the field (e.g. technology transfer, products, patents in the case of exact sciences; products and services in the case of social and humanities; festivals, competitions, recitals, sports competitions; cultural-artistic commands in the vocational field; presentations at national and international conferences, publication of research results in national and international publications, involvement of doctoral students in the development of research and development projects, etc.).

PhD students were involved in:

- -artistic activities (recitals, shows, concerts -352)
- -scientific activities (publications -84,
- -symposia, conferences -32)
- -other activities (judgments, participation in editorial teams and projects) -23
- -research and development projects -18
- and received 47 awards and two diplomas of merit.

Fulfilled

Criterion B.4. The quality of doctoral thesis

Standard B.4.1. Doctoral thesis meet high quality standards.

Performance Indicator B.4.1.1. At the IODS level, the percentage of invalidated theses, without the right to redo and resume the public support process, at the level of the CNATDCU General Council, is at most 5% in the last five years.

Within IODS NAMGD no case of invalidation without the right to redo the doctoral thesis was registered from the CNATDCU General Council

Domain C. QUALITY MANAGEMENT

Criterion C.1. Existence and regular development of the internal quality assurance system

Standard C.1.1. The institutional framework exists and a procedure for monitoring internal quality assurance as well as relevant internal quality assurance policies is applied

Performance Indicator C.1.1.1. IODS has developed and periodically applies a procedure for evaluation and internal monitoring of the activities within the doctoral schools, among the evaluated criteria being mandatory:

- a) the scientific activity of the doctoral supervisors;
- b) the infrastructure and logistics necessary for carrying out the research activity;
- c) the regulations and procedures on the basis of which the doctoral studies are organized;
- d) social and academic support services (including participation in various events, publication of articles, etc.) and counseling provided to doctoral students;

The institution has a strong internal quality culture, supported by clear and effective quality assurance and enhancement procedures. Improving the quality of education consists of actions and corrective measures adopted on the basis of systematic analysis and continuous evaluation of the activity of the institution.

The Quality Manual exists, applies and includes the related procedures, including:

- Procedure regarding the monitoring and improvement of the activities of teachers, research and auxiliary involved in university study programs;
- Procedure regarding the periodic evaluation of teachers by management;
- Procedure regarding the peer evaluation of teachers;
- Procedure regarding the elaboration of curricula
- Procedure for monitoring graduates' careers

Recommendation:

I would recommend that portions of internal quality assurance and enhancement results be published, so as to encourage Academy wide reflection on improving problematic areas: internal quality assurance mechanisms should provide good feedback and thus encourage improvement. More generally recommendation should be about the formal policy that needs to be implemented to share internal quality assurance results – the Academy is a relatively small community where people all know each other and as such, there tends to be a degree of informality which can discourage formalizing certain procedures. Were internal assurance quality results to be clearly

visible, this could affect internationalization positively: such transparency is appealing to international students.

Performance Indicator C.1.1.2. The student associations and, as the case may be, the representative students organize elections among the doctoral students, for positions in CSUD, by universal, direct and secret ballot, all doctoral students having the right to choose and be elected.

The CDS Student Election Regulations and Evidence Reports exist and apply.

In accordance with the legislation in force, the Student Association appoints representatives from among doctoral students for positions in the Council of Doctoral Studies (CSUD), by universal, direct and secret ballot of the students.

Fulfilled

Performance Indicator C.1.1.3. Student associations and, as the case may be, representative students organize elections among doctoral students, at the level of each doctoral school, for positions in doctoral school councils, by universal, direct and secret ballot, all doctoral students having the right to elect and be elected.

There are and apply the Regulations for the election of students in the Doctoral School and Evidence Reports.

Fulfilled

Performance Indicator *C.1.1.4. Following the internal evaluation, both IODS and the doctoral schools develop strategies and action policies in order to remedy the reported deficiencies and to stimulate the scientific and academic performance of IODS.

It is applied the *Procedure for monitoring and improving the activities of teachers, research and assistants* involved in university study program and *Procedures for internal evaluation of the quality of the doctoral study program,* in order to evaluate and stimulate scientific and academic activity.

Recommendation:

I would recommend the long-term strategy be prioritized to become a veritable road map, integrating a time line within which specific goals can be achieved.

Fulfilled

Criterion C.2. Transparency of information and accessibility to learning resources

Standard C.2.1. The information of interest for doctoral students, future candidates, respectively the information of public interest are available for consultation in electronic format.

Performance Indicator C.2.1.1. The IOSUD publishes on the website of the organizing institution, in compliance with the general regulations on data protection, information such as:

- a) the regulations of the doctoral school;
- b) the admission regulation;
- c) the doctoral studies contract;
- d) the regulation for completing the studies, which should also include the procedure for public defense of the thesis;
- e) the content of the study programs;
- f) the scientific profile and thematic areas / research topics of the doctoral supervisors in the field, as well as their institutional contact data;
- g) the list of doctoral students in the field with the basic information (year of registration; supervisor);
- h) information about the standards for the elaboration of the doctoral thesis;
- i) links to the abstracts of the doctoral theses to be defended publicly, as well as the date, time, place where they will be defended, at least 20 days before the defense.

The doctoral school updates and manages on the university website information related to the activities of the doctoral school and ensures access to regulations, procedures and information related to the activities of the doctoral school, in compliance with the general regulations on data protection.

Fulfilled

Standard C.2.2. The IOSUD/The Doctoral School provides doctoral students with access to the resources needed to conduct doctoral studies.

Performance Indicator C.2.2.1. All PhD students have free access to a platform with academic databases relevant to the fields of organized doctoral studies

Students and teachers have access to the following databases:

- 1. Grove
- 2. RILM -EBSCO host Login
- 3. Cambridge Journals
- 4. JSTOR -link:
- 5. Music and Dance Online

The access of doctoral students to periodicals in the field, in the country and abroad, to databases including international JSTOR and Journal of Research in Music Education and to the Internet is unrestricted.

Recommendation:

I would recommend access to more databases: Naxos Music Library, Naxos Video Library and Naxos Library Jazz, Wiley-Blackwell, Elsevier, Springer and Web of Knowledge.

Fulfilled with recommendation

Performance Indicator C.2.2.2. Each doctoral student has access, upon request, to an electronic system for verifying the degree of similarity with other existing scientific or artistic creations.

Access to the sistemantiplagiat.ro platform can be obtained at the request of students.

Fulfilled

Performance Indicator C.2.2.3. All doctoral students have access to scientific research laboratories or other facilities depending on the specifics of the field / fields within the doctoral school, according to internal rules.

The regulations of the Doctoral School stipulate that the research laboratories, the lecture halls, the library, the study rooms equipped with instruments, all the spaces with internet access are at the disposal of the doctoral students.

Fulfilled

Criterion C.3. Degree of internationalization

Standard C.3.1. There is a strategy and it is applied to increase the degree of internationalization of doctoral studies.

Performance Indicator * C.3.1.1. IODS, for each doctoral school, has signed mobility agreements with foreign universities, with research institutes, with companies that carry out activities in the studied field, which aim at the mobility of doctoral students and teachers (for example, ERASMUS agreements for the study cycle doctoral degree). At least 35% of PhD students have completed a training course abroad or another form of mobility, such as participating in international scientific conferences. IODS develops and implements policies and action plans aimed at increasing the number of doctoral students participating in training courses abroad, up to at least 20%, which is the target at the level of the European Higher Education Area.

In the period 2015-2020, 53 mobility agreements were concluded with the "Gheorghe Dima" National Academy of Music, also valid for doctoral students. The number of PhD students who wanted and benefited from ERASMUS mobility is 12. The number of mobilities is complemented by the large number of doctoral students who have professional commitments abroad.

Recommendation:

I would recommend a stronger emphasis placed on international educational environment and on the international dimension in curriculum development.

In addition to the activities carried out through the Service of International Relations and Community Programs-UNMB, ERASMUS, IOSUD-UNMB concludes partnerships with profile institutions that carry out activities of international prestige, creating the possibility for doctoral students to participate at such international level events.

IODS constantly monitors and evaluates these practices and can demonstrate their application to all activities and the involvement of students in all these processes, and the results of the monitoring are made public annually or whenever necessary

- b) exclusion from IODS of the doctoral supervisor who coordinated at least two doctoral theses with a final decision to withdraw the doctoral degree for plagiarism."

Performance Indicator *C.4.1.6. Scientific reviewers who have been part of the public support commissions of two or more doctoral theses with a final decision to withdraw the doctoral degree for plagiarism have not been appointed to the public support commissions of doctoral theses for a period of at least 3 years.
