- preparing the Action Plan on Recommendations of the ECAQA External Expert Commission (EEC) for 2022-2027 and submitting the original approved plan to ECAQA by July 31, 2022.

- submitting annual reports to ECAQA by December 20 each year from 2023 through June 2027:

- 1) Report on the Implementation of Measures to Improve the Educational Programmes of the University in Accordance with the Recommendations of the ECAQA External Expert Commission for \_\_\_ (year).

The reports shall be drawn up in tabular form, in accordance with the Action Plan, and include the date of implementation, information on the implementation of the corrective measures and evidence of their implementation (document outputs, etc.), while the university is required to generate an appropriate annex with approved copies of supporting documents when sending the reports. The reports shall be approved and endorsed by the chief executive of the university.

- if it is reasonably required, arranging a one-day visit of an ECAQA expert and coordinator to the university two (2) years after the date of the accreditation certificate in order to obtain evidence of the implementation of the recommendations of the External Expert Commission. No additional funding from the university is required. The date of the expert visit shall be determined upon agreement with the administration of the educational organisation.
