Non-profit Institution "Eurasian Center for Accreditation and Quality Assurance in Higher Education and Healthcare" (ECA) informs you about the decision of the Accreditation Council to accredit the educational programmes of residency specialties of Kazakhstan Medical University (KMU) "Graduate School of Public Health" according to the list below for the period of 5 (five) years from 20.02.2025 to 19.02.2030 with the following conditions:

- 7R01124-Otorhinolaryngology (adult, pediatric)
- 7R01107-Cardiology (adult, pediatric)
- 7R01103-Neonatology
- 7R01122-Dermatovenerology (adult, pediatric)
- 7R01109-Gastroenterology (adult, pediatric)
- 7R01116-Psychiatry (adult, pediatric)
- 7R01136-Endocrinology (adult, pediatric)
- 7R01132-Physical Medicine and Rehabilitation (adult, pediatric)
- 7R01135-Adult Oncology.

The Accreditation Council, having made a decision on accreditation for the full period, defined the following as conditions:

- 1) KMU "Graduate School of Public Health" during the period of post-accreditation monitoring should annually provide ECAQA with information on the results of independent evaluation of graduates and employment indicators of graduates of ECAQA-accredited educational residency programmes. It is recommended to include the information in the annual Reports on the implementation of recommendations of the ECAQA external expert commission.
- 2) ECAQA within the framework of post-accreditation monitoring should plan a one-day visit of an accreditation expert and an observer from ECAQA to KMU "Graduate School of Public Health" in February 2027 in order to assess the

implementation of the recommendations of the ECAQA external expert commission. The visit should be carried out at the expense of ECAQA. The date should be agreed with the university administration.

Along with this letter we are sending the original accreditation certificates of the above residency programmes.

The Reports of the external expert commission and the decision of the Accreditation Council will be posted in the European Quality Assurance Register for Higher Education (EQAR-DEQAR), in the Asia-Pacific Quality Register for Higher Education (APQR-DAQAR) and on the ECAQA website in the "Register" section https://www.ecaqa.org/en/reestr-en.

Information about accredited residency programmes will be published in the EHEA information system of the Ministry of Science and Higher Education of the Republic of Kazakhstan https://epvo.kz/#/ in the section "Register of accredited educational programmes".

Post-accreditation monitoring in accordance with the accreditation process is carried out by ECAQA for five years until January 2030 and includes the provision of an annual Report on the implementation of the recommendations of the external expert commission.
