1. The Register Committee considered the Substantive Change Report of 2021-09-01.
2. The Register Committee took note of the recent change in EAEVE's SOP 2023 regarding its follow up. The Committee learned that the agency now requires that all member establishments of EAEVE send Interim reports to the agency 3 and 5 years after the Full Visitation. In addition, the Committee has learned that for establishments that were accredited with Minor Deficiencies, an additional Interim Report must be sent to EAEVE one year after the Full visitation, focusing on the correction of the Minor Deficiencies.
3. The Register Committee took note of the change.

Description new/changed	<p>The European System of Evaluation of Veterinary Training (ESEVT) evaluation process is a fully transparent international accreditation procedure. Periodic evaluation is compulsory for EAEVE members, currently every 7 years. Four types of evaluation are organised:</p> <ol style="list-style-type: none">1. Preliminary Visitation (PV)2. Full Visitation (FV)3. Re-visitation (RV)4. Interim Report (IR) <p>According to the SOP 2019, an Interim Report</p>

must be sent by all Veterinary Education Establishment (VEEs) that are members of EAEVE 3.5 years after the (full) Visitation. In the SOP adopted in 2023 the following change was introduced:

3 years and 5 years after the Full Visitation, all VEEs that are members of EAEVE must send concise Interim Reports to the EAEVE Office.

For VEEs which have been accredited by ECOVE with Minor Deficiencies, an additional Interim Report must be sent to the EAEVE Office one year after the Full Visitation focussing on the correction of the Minor Deficiencies.

In case of absence of an Interim Report or evidence in the Interim Report of potential major issues, ECOVE may ask for further information from the VEE
