- 1. The Register Committee considered the two Substantive Change Reports of 2024-12-13.
- 2. The Register Committee noted that ACCUEE introduced two new external QA activities:
 - a) Institutional Accreditation
 - b) AUDIT Certification of Internal Quality Assurance Systems
- 3. The Register Committee took note that the agency introduced these two activities following its registration on EQAR, while the same were previously coordinated by ANECA at higher education institutions on the Canary Islands. The Committee understood that the procedures are based on the provisions developed by ACCUEE are based on the current protocols of the Spanish Network of University Quality Assurance Agencies (REACU).
- 4. Based on the detailed information provided in the Substantive Change Report the Register Committee had no concerns that the ESG are complied with.
- 5. The Register Committee expects that the new activities, Institutional Accreditation and AUDIT, will be analysed in full against ESG 2.1 2.7 as part of the next external review of ACCUEE.
