- 1. The Register Committee considered the Substantive Change Report of 2022-06-22.
- 2. The Register Committee took note of AAC-DEVA starting to use the European Approach and publishing the associated <u>Guide for the Evaluation of International Joint Programmes within the European Approach for Quality Assurance</u>.
- 3. In its Guide, AAC-DEVA added no additional requirements or limitations, but spelled out how in greater detail how it implements the European Approach, including report templates that AAC-DEVA uses.
- 4. Given that AAC-DEVA uses the European Approach without substantial modification, the Register Committee was assured that the ESG are complied with. The Committee nevertheless expects that this activity be analysed in full as part of AAC-DEVA's next review for renewal of registration.

The selection of the review panel for the assessment of international joint degrees is specifically conducted for this purpose by AAC-DEVA in coordination with the QA agencies operating in the respective countries in which the joint programme is going to be offered. The panel will be composed of five people, including one student and representatives of at least two countries involved in the consortium.

In accordance with AAC-DEVA's procedure for the Selection of the review panel for joint degrees evaluation according to the European Approach, the final panel will be decided by a commission composed of the responsible person coordinating the International Relations Area, the responsible person coordinating the Area for University Evaluation and Accreditation and an AAC-DEVA's technician, and it will remitted for its official approval to the AAC-DEVA's Director.

After confirming participation, evaluators will sign their appointment, which entails the acceptance of the AAC-DEVA's Ethical Code, ensuring
