II. Accreditation Report Executive Summary

General Information on Education Pogramme⁴

Accreditation has been conducted for higher educational programme of the Kutaisi University grouped in a cluster "Travel, Tourism and Recreation": "Tourism" – Bachelor's Educational Program. Bachelor's programme "Tourism" was granted accreditation in 2011.

The volume of the undergraduate educational program "Tourism" is 240 credits including the main Major program - 180 credits, additional Minor program - 60 credits; the duration of the program is 4 (four) academic years, i.e. 8 (eight) semesters, and includes 240 ECTS (6000 hours).

Overview of the Accreditation Site Visit

The accreditation visit to KU was carried out by the team of experts on May 11 and took Accreditation has been conducted for higher educational programme of the Kutaisi University grouped in a cluster "Travel, Tourism and Recreation": "Tourism" — Bachelor's Educational Program. Bachelor's programme "Tourism" was granted accreditation in 2011.

The volume of the undergraduate educational program "Tourism" is 240 credits including the main Major program - 180 credits, additional Minor program - 60 credits; the duration of the program is 4 (four) academic years, i.e. 8 (eight) semesters, and includes 240 ECTS (6000 hours). Accreditation site visit took place according to the pre-developed agenda. Interviews were conducted with Rector, Vice-Rector and Head of Administration, Dean, representatives of the Quality Assurance Office, Self-Evaluation Team, Head of the BA programme, academic and invited staff, students, alumni, and representatives of employers.

In addition to the interviews, it has been conducted the review of resources and HEI's infrastructure. The visit was progressing in a collegial and constructive environment.

• KU's study programme Tourism mostly complies with the all standards.

Recommendations

- The cooperation with employers regarding potential improvements of study programme should be strengthened.
- Update of the literature in some courses syllabi is needed.

Suggestions for Programme Development

- The amount of lectures by invited staff from organizations could be increased.
- Institution might consider introducing recognition of practice for employed students.
- Pedagogical training of practice mentors from organizations would be beneficial.
- Increase the familiarity with soft skills, before the students enter practice.

A programme has clearly established objectives and learning outcomes, which are logically connected to each other. Programme objectives are consistent with the mission, objectives and strategic plan of the HEI. Programme learning outcomes are assessed on a regular basis to improve the programme. The content and consistent structure of the programme ensure the achievement of the set goals and expected learning outcomes.

1.1 Programme Objectives

Programme objectives consider the specificity of the field of study, level and educational programme, and define the set of knowledge, skills and competences a programme aims to develop in graduate students. They also illustrate the contribution of the programme to the development of the field and society.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

It has been ascertained that the mission, vision and values of the Kutaisi University (KU) are reflected in the bachelor study programme of Tourism. KU presented a table of correspondence between the mission of the university and the objectives of the study programme of Tourism, which demonstrates this compatibility. Experts confirm that the evaluated educational programme objectives lead to formation of competitive, socially responsible specialists in tourism, able to demonstrate their competencies when entering the labor market. Programme objectives are achievable and realistic.

During the interviews it has been confirmed the important role to the development of the field and the implementation of the national-state interests of Georgia.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

Graduate of the bachelor educational programme Tourism at the KU achieve the following learning outcomes: 1. Describes the theoretical-methodological, organizational bases of the main functional areas of business and their interrelationships; Critically understands the theories of business environment regulation, complex issues of concepts and principles; Ways to increase the peculiarities and efficiency of tourism business activities; National and global economic environment of tourism; 2. Considers the role of consumption, savings and investment in the development of the tourism economy; Processes of activities in the field of tourism, issues of planning, implementation and management of tourism products and services; The results of the activities of the tourism enterprise, the driving forces of competition; 3. Identifies the qualitative characteristics of the tourist-recreational resources and potential of other countries of Georgia; Distinguishes the specialization of Georgian resort-recreational economy; 4. Presents the means and methods of obtaining marketing information, marketing and sales management principles; Collects and analyzes marketing data based on data collection, evaluation and linking trends in global and local tourism markets; Highlights perspective directions of tourism activities; Market segmentation, target market, develop new tourism product and customer-friendly marketing offers; 5. Uses proven methods and tools for the implementation of tourism activities, analyzes the results of a separate segment in the field of tourism; Prepares quality, safety and sustainable development programs in the tourism industry; 6. Discusses the solution of problems and achieves the desired results with specialists and non-specialists in the field of tourism, orally and in writing, argues his / her position, prepares public presentations and business documents using industry terminology and relevant information and communication technologies; 7. It has been established through the documentation review and interviews with graduates and employers that the learning outcomes defined by the program correspond to the program objectives, which is also demonstrated by the programme objectives and learning outcomes correspondence map presented in the self-evaluation report.

The learning outcomes of the study programme are clearly defined, achievable and measurable, as evidenced by the learning outcomes map. The map clearly represents which training course will ensure the achievement of a specific outcome of the study programme. The map also shows to what degree it is possible to achieve a specific result (appendix No. 2 - Map of learning outcomes of the educational program).

Experts confirm that the learning outcomes of the bachelor study programme Tourism at KU correspond to the sixth level of the higher education qualifications framework (the first level of higher education - baccalaureate), detailed field descriptor and the qualification to be awarded.

The learning outcomes of the programme are perfectly in accordance with the qualifications awarded (Bachelor of Business Administration in Tourism).

The programme ensures the achievement of learning outcomes correspond to the National Qualifications Framework descriptions. Graduates are able to continue their studies on the master level.

All interested parties were involved in the development of the study programme. They expressed some recommendations, which were also included into the programme (e.g. Russian, German, and French language are now provided as optional courses, while sectoral English language was added to the curriculum as a compulsory course). Attached documents Stakeholder Survey Results Analysis and Results Utilization Report confirm this collaboration.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

KU rector approved the Methodology for the Assessment of the Learning Outcomes of the Educational Program in 2020, and this document is the basis for the evaluation of the student's achievement of the learning outcomes.

Learning outcome assessment map was defined with indicators for each learning outcome. They are used to evaluate the achievement of the learning outcome through five evaluation levels. These are: does not satisfy at all, does not satisfy, satisfies, largely satisfies, completely satisfies. Assessment rubrics are presented for each indicator and each assessment level.

Experts agreed that the programme learning outcomes evaluation cycle consists of defining, collecting and analyzing data necessary to measure learning, as intended.

At the KU they analyze what percentage of students in each learning component receive an A grade and an F grade. If more than 10% of students constantly receive a negative grade: F (failed) or if more than 10% of students consistently receive the highest grade: A (excellent) it is considered to apply special attention and study the problem.

When the analysis showed that a response is needed, they researched the roots of the problem through focus group and finally decided how to eliminate the problem. Among the possible reactions within the programme or course it is possible to change: teaching and learning methods, contact hours with the lecturer, or the assessment methods, etc.

As the content of the programme was updated in the 2020-2021, it wasn't possible to compare the results with the data of three years in total. But nevertheless, the statistics of academic performance and the analysis carried out were discussed at the committee meetings and meetings with students, the program leader, and the staff implementing the course. Teaching-learning methods in the syllabus of the Business Fundamentals course were modified, and the course was updated with more practical activities.

Also surveys of graduates and employers and analysis of survey results are used as an indirect method of evaluating learning outcomes set by the program, which indirectly allows the evaluation of the achievement of the learning outcomes of the program.

It has been ascertained that the programme learning outcomes assessment results are utilized for the improvement of the evaluated programme.

1.4. Structure and Content of Education Programme

- > The Programme is designed according to HEI's methodology for planning, designing and developing of education programmes.
- > The Programme structure is consistent and logical. The content and structure of the programme ensure the achievement of programme learning outcomes. The qualification to be granted is consistent with the content and learning outcomes of the programme.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

KU developed study programme Tourism in accordance with the "procedures for planning, developing, approving, developing, making changes and cancelling educational programs" (approved by the rector, document No. 14 of September 17, 2020).

The duration of the programme is 4 (four) academic years, 8 (eight) semesters, and includes 240 ECTS (6000 hours). Components of the main field of study represent a volume of 180 credits. Among them, are the compulsory components of the main study field with a volume of 165 ECTS, and the elective components of the main study field with a volume of 15 ECTS. There are free components with the volume of 60 credits, which are focused on the development of general/transferable skills, including the mandatory training courses of the free component with the volume of 50 ECTS and the optional training courses of the free component with the volume of 10 ECTS.

The study programme envisages mandatory confirmation of knowledge of the English language at the B2 level or demands such achievement within the programme. The student confirms the level of knowledge of the English language in accordance with the "Rules for determining the language competence of Kutaisi University students". Syllabusses

Experts agree that the study programme offers a logical sequence of the formation of achievable competencies, determined by its content, structure, and curriculum. Prerequisites for admission are determined, as it is their sequence, the semester distribution of the credits of the components, the semester load of the student. It is also true that the content, scope, and structure of the study programme Tourism ensure education appropriate to the level of the program and the qualification awarded by the program (Bachelor of Business Administration in Tourism). Employers present at the interview didn't show proper understanding what is their role in the updating and improving of the study programme.

Employers expressed the opinion, that students when coming to practice lack general soft skills, like communication, teamwork and other interpersonal skills.

Syllabuses have been checked, they use Georgian-language literature and English-language literature (as additional literature), this makes possible the transfer of international and modern achievements in the field. But there are some courses which prescribe obsolete literature.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

It has been established through the study of the documentation and interviews with various groups of stakeholders, that the learning outcomes of the study courses of the main field of study provided by the tourism study programme Tourism correspond to the learning outcomes defined by the

programme, and thus, their unity ensures the achievement of the learning outcomes set by the programme.

Experts have scrutinized the proposed map of learning outcomes. It has been established that every compulsory study course of the main field corresponds to at least one learning outcome of the evaluated programme and vice-versa.

The content and number of credits (volume of contact and independent hours) of all training courses provided by the program ensure the achievement of learning outcomes. Compulsory literature and other learning resources correspond to courses' learning outcomes. Compulsory literature and other teaching and learning resources listed in the syllabi also consider the latest research in the relevant field taking into account the specifics of the academic course, except for some courses: Tourism and Hospitality Management; Excursion Science and the Art of the Guide; and Marketing of Services.

Adequacy of the ratio of lecture and practical hours is also considered within the educational program's training courses. In courses focused on developing students' practical skills, most contact hours are devoted to group work/practical learning hours.

In order to achieve the learning outcomes of the programme's study courses, adequate teaching-learning methods and activities are provided by the implementing staff within the framework of each course.

Forms and methods of assessment of learning outcomes used within the study course are described in the syllabus of each study course. they are appropriate.

The number of credits allocated for each study course of the bachelor's program corresponds to the content of this course, and the ratio between contact and independent hours is adequate and takes into account the specifics of the study course.

The HEI has relevant, transparent, fair, public and accessible programme admission preconditions and procedures that ensure the engagement of individuals with relevant knowledge and skills in the programme to achieve learning outcomes.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

To enrol in the study programme Tourism, the applicant is obliged to pass the following subjects at the unified national exams: Georgian language and literature, (the entrant must pass the minimum competence limit established by the legislation); one of the following subjects from foreign languages: English language; German language; French Language; Russian language (the entrant must pass the minimum level of competence established by law); or one of the following subjects: history/mathematics/geography (the applicant must pass the minimum competence limit established by the law).

Based on the order of December 29, 2011 No. 224/N of the Minister of Education and Science of Georgia, persons might enrol in the programme also without passing the Georgian unified national exams. The same is possible for students on mobility.

Based on the above, the prerequisites for admission to the program are in accordance with the legislation in force in Georgia and ensure the admission of persons with the necessary knowledge and

skills to achieve the learning outcomes of the program. Information about the conditions for enrolling in the program is posted on the Kutaisi University website and is available to any interested person: https://www.unik.edu.ge/.

2.2. The Development of Practical, Scientific/Research/Creative/Performing and Transferable Skills

Programme ensures the development of students' practical, scientific/research/creative/performing and transferable skills and/or their involvement in research projects, in accordance with the programme learning outcomes.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

The study programme Tourism allows the development of the student's practical, scientific/research and transferable skills. The practical component in the program is presented both as a practical component embedded in separate study courses and as an independent component, with a volume of 6 ECTS.

Used methods like problem-based learning, practical exercises, case analysis, cartographic training, teamwork, brainstorming, preparing a project etc. ensure the development and strengthening of practical skills.

Memorandums are stipulated with fourteen organisations to implement the practical component; each student spends 90 hours at one of these organisations. The selected organizations are

appropriate for the field for which the students of the programme Tourism are being educated. There is no information about the pedagogical experience and knowledge of mentors coming from these organisations.

Students are able to gain their research skills through courses "Business Research Methods" (5 ECTS), and "Academic Writing" (5 ECTS). Development of information, data acquisition, processing, analysis and interpretation skills is provided within these courses. There is also the task to develop a project (5 ECTS) in the 8th semester, which also serves to develop the research skills of students. The bachelor's project is completed in accordance with the "Rules for the completion of the bachelor's thesis" developed at Kutaisi University (approved by Rector on September 28, 2020 No. d36) in compliance with the general requirements and the additional requirements stipulated in the bachelor's project syllabus.

KU has developed "procedures and mechanisms for plagiarism detection, prevention, and response to plagiarism cases" (approved by the University Rector's Order No. 23 of September 17, 2020). They are using anti-plagiarism electronic program: StrikePlagiarism.com, which helps to detect plagiarism and provides students with academic communication skills. Students and staff attend different activities to increase the awareness of the importance of academic integrity.

Experts confirm that the study programme is implemented by using student-centred teaching and learning methods and that they correspond to the level of studies within the evaluated study programme.

The activities which are provided for teamwork and during practical training are: discussion/debate, teamwork, PBL - problem-based learning, action-based learning, TBL - task-based learning, case study, work on the book (source) and written work, induction, deduction, analysis, synthesis, brainstorming, teaching with electronic resources (E-learning), project-based learning, cartographic teaching, presentation, role-playing (business) game / simulation, the Socratic approach. Used methods are relevant and internationally comparable to similar programmes. They are suitable for transferring knowledge and strengthening students' competencies.

Experts have checked the compliance of the teaching and learning methods used within the program with the learning outcomes of the program and also to evaluate the achievement of the learning outcomes using them, with the aid of a map of the compliance of the teaching and learning methods with the learning outcomes. Student evaluation is conducted in accordance with the established procedures. It is transparent, reliable and complies with existing legislation.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

It has been ascertained that the evaluation system used within the programme is in accordance with the "Rules for calculating credits for higher education programs" approved by Order No. 3 of the Minister of Education and Science of Georgia on January 5, 2007.

For the intermediate and final evaluations of students' knowledge, diverse methods are being used, determined by the course staff. Among them are: test, open questions, essay, oral survey, discussion/debate, case/situation analysis, practical assignment, quiz, project, literature review, presentation, narration, listening, writing, and teamwork.

There are five types of positive assessment, from E to A, and two negative grades. First one is (FX) Didn't pass (on the first attempt) -41-50 points, which means that the student needs more work to pass and is allowed to take one additional exam with independent work; and (F) Failed -40 points or less, which means that the work done by the student is not sufficient and he/she has to retake the course.

Practice is being performed taking into account the instructions of the practice supervisor. At the end of the practice, the student writes a report, according to a predetermined form, and defends it before the commission. The knowledge and skills acquired by the student within the scope of the practice are evaluated by an intermediate assessment (60 points), which includes the assessments of the head of the practice and the mentor, and by a final assessment (40 points), during which the student presents a report on the practice.

The bachelor's project is evaluated according to the "rules for the execution of the bachelor's thesis" developed at Kutaisi University (approved by the order of the rector of the university dated September 28, 2020 No. d36) to evaluate the approaches established and provided for by the bachelor's project syllabus. The bachelor's project is evaluated by midterm and final evaluations.

Student evaluation procedures are transparent and fair to all students, students have the possibility to appeal regarding the received grade.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

Kutaisi university takes into consideration the needs and interests of its students in order to offer them a better quality of Education. They use questionnaires to gather some data about students' needs and what they like about the program and what are some aspects they would like to change or improve. They use different types of questionnaires, some are used to understand what students think about the program and about the lecturers, how satisfied students are with the program; some are about general topics that students would like to change in general in the university or if they wish to plan something. Students' participation in this questionnaire is anonymous.

Whenever students of this program plan to have any kind of activities, feel free to ask the coordinator of their program and share their ideas and fulfil their plans.

Students have a chance to use the consultancy hours with the lecturers whenever they need to. They may visit them and get some kind of information or help after lectures. Students also mentioned that they are not restricted with specific times and days, they can use consultancy hours whenever there is a need for it.

There are several positive aspects that should be mentioned. Firstly, students have an opportunity to participate in different projects and prepare speeches. They can also use a chance and become exchange students but there is one factor which hinders some students from participating in the exchange programs, this is a language barrier. Not every student possesses the appropriate level of English language to become an exchange student. University offers some job fair events as well where students can meet the employers.

Students are informed about various local and international projects and events that are consistent with their teaching and research objectives.

After the meeting with the employers, a problem connected to insufficient language knowledge was shown at this stage as well.

After the discussion with the graduates of this program, students mentioned that some programs are updated and modified and it is much better now than during their study years.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

Based on the self-evaluation report of the educational program, the documentation attached to it, and the information obtained as a result of the accreditation visit, we outline that 40 academic personnel are involved in the undergraduate tourism educational program implementation process, including 17 academic and 23 invited personnel. Among the academic staff, there are 5 professors (including 3 affiliated ones), 10 associated professors (including 4 affiliated), and 2 assistant professors (both affiliated). As a result of the study of the documentation submitted by the Higher Educational Institution and already carried out interviews, it was determined that the institution has developed and has been using the "Methodology for Determining Number of the Academic and Invited Staff", according to which the minimum number of academic staff involved in the educational program implementation process, is calculated based on the hours, spent in the mandatory academic courses of the program's major field of study, considering the number of students with active status (Rector's Order No. 16 of September 17, 2020).

There is the document "Kutaisi University Staff Selection Rule" (Rector's Order No. 261 of July 16, 2020) operating at the Higher Educational Institution, according to which the academic staff implementing the program is selected by the competition. As a result of checking the documents confirming the qualifications of the professors and invited staff involved in the program implementation process, presented by the Higher Educational Institution, as well as the carried out interviews with the academic and invited staff at the university, we outline that the people executing the program are in accordance with the legislation and internal regulations of the Higher Educational Institution. The expertise of personnel is in conformity with their qualification requirements, functions, and proper legislation.

The Higher Educational Institution has developed a "Semester Workload Scheme" for the academic and invited staff involved in the educational program implementation process, which ensures the proper execution of the educational process defined by the educational program, as well as the performance of scientific-research activities and other functions assigned to them. The study program syllabus also defines the number of counselling hours. The number of academic and visiting staff is adequate for the number of students. The ratio between academic and visiting staff ensures the sustainability of the programs. As a result of the study of the document "Quantitative Data of the Educational Program", presented by the Higher Educational Institution, and the conducted interviews, we emphasize that the rate of intensity of academic and invited staff turnover ensures the durability of the program.

The study of the documentation submitted by the Higher Educational Institution and the results of the interview with the program manager demonstrated that the program manager has the crucial professional knowledge, experience, skills, and competence for program development and successful implementation. The supervisor is actively involved in the program implementation, evaluation and progress, counselling of students, and various events planned within the framework of the program.

The visit to the institution revealed that the educational program is implemented with the support of the university administration and all relevant structural units. The administrative and support staff qualifications are in accordance with the duties assigned to them and the functions to be well performed.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

Based on the self-evaluation report of the educational program, the documentation attached to it, and the information obtained as a result of the accreditation visit, we outline that the evaluation of the staff implementing the bachelor's education program in tourism at Kutaisi University is carried out in several directions, namely:

- 1. Academic staff is evaluated according to the carried out scientific and research activities;
- 2. Academic and guest staff are also evaluated according to their academic activities (the evaluation process is regulated by the "Rule of Evaluation of Academic and Invited Staff of Kutaisi University LLC"), which means staff evaluation by the student, dean, program head, examination centre employees and training process management supervisors;
- 3. Evaluation of program implementation staff, which involves assessment of in-class activities. The evaluation process is regulated in accordance with the "Procedures for Evaluating the Auditorium Work of Kutaisi University LLC" (Rector's Order No.17 of September 17, 2020).

According to the interviews, the summary assessment results and the feedback are sent by the quality assurance service to the academic and visiting staff individually. It is important that, as a result of in-class activity assessment, the institution frequently offers various training courses to academic and visiting staff in order to improve the quality of teaching. The Center for the Promotion of Scientific and Research Activities is operating in the institution, which, in cooperation with the quality assurance service, evaluates the obtained results, analyses and determines the needs for the promotion of scientific and research activities for the academic staff, and plans the relevant activities. The institution also has a financial promotion mechanism for scientific and research activities, which provides financial incentives for academic and invited staff once a year. As a result of the interviews with the academic and invited personnel, it was revealed that the mechanisms and methods of their evaluation by the quality assurance service are known to them in advance, and they positively assess the ongoing process, actively participate and contribute to the process management. The active student involvement in the evaluation lecturers and training courses is also significant, which was outlined during the interviews with them.

There is an International Relations Department, operation in the Higher Educational Institution, which ensures the cooperation of students and professors with foreign educational and scientific entities. The Center for the Promotion of Scientific Research Activities of Higher Educational Institutions provides individual consultations and conducts training sessions for obtaining funding for scientific projects and international events from donor organisations.

Training sessions, workshops, and informational meetings are regularly held by the Center for the Promotion of Scientific and Research Activities, considering the needs and requirements of the personnel. It is important that 77,600 GEL has been allocated to the budget of the faculty for the financing and promoting of the scientific-research activities of the academic staff. Also, 10,000 GEL is provided in the budget of the faculty to finance scientific research projects.

Interviews with academic and invited staff of the program showed that the program personnel are actively involved in international projects and conferences, they publish research papers in international scientific journals.

After having interviews during the site visit and reviewing the self-evaluation report and its annexes provided by the Kutaisi University group of experts concluded that university Quality Assurance (QA) service carries out its activities in accordance with the the "Quality Assurance Policy". The quality assurance system works according the principle of »plan, implement, test, develop«. QA service mobilises and prepeares data, information and reports related to the program and self-evaluation reports.

Working group/program comitee and leader of program together with the QA service began preparation of educational program with the analysis of the job market. In the process of working on update of the content of the educational program program leader had systematic

communication with the administration and QA service. In order to consider the best practices, analogical programs from Georgian and foreign institutions were analysed.

For monitoring and evaluation of the electronic/distance learning process Kutaisi University ensures the adaptation of internal quality assurance mechanisms by introducing special procedures and regulations for it, by development of special questionnaires about the quality of electronic/distance learning and by conducting the special surveys about electronic/distance learning.

Summary and Analysis of the Education Programme's Compliance with the Requirements of the Component of the Standard

In the 2020-2021 academic year, certain changes were made within the framework of the educational program. The basis of the mentioned changes was the results of the external evaluation, as well as the internal mechanisms of quality assurance developed in the university for the purpose of developing educational programs. The evaluation of the educational program by the Georgian National Center for Educational Quality Enhancement was carried out through unplanned monitoring. As a result of the monitoring of the tourism undergraduate education program, out of three standards (first, second and fourth standards), the program was evaluated in two standards (first and fourth standard) as fully compliant with the requirements, and in one (the second standard) as substantially relevant. The program was given recommendations and advice. University was obliged to submit a report on the implementation of the received recommendations within 6 months. The University submitted to the National Center a report on the implementation of the recommendations and advice received within the framework of the monitoring of the undergraduate education program in tourism. By the decision of the Accreditation Council of Higher Education Programs of April 1, 2022 (Decision No. MES 8 22 0000341650), the administrative proceedings started in connection with the unplanned monitoring of the program were terminated. "Tourism" was defined as the name of the educational program.

The undergraduate tourism education program was sent to an external evaluator from another Georgian institution of higher education for formative assessment. It was positively evaluated by an independent expert. The evaluator expressed certain recommendations, some of which were taken into account in the process of updating the program.

The University has in place the mechanizms for the educational program evaluation. It is evaluated by the program leaders annually. The evaluation consists of different components, like evaluation of the achievement of the learning outcomes, analysis of the academic performance of students, results of the survey of interested parties/stakholder, indicators of employment of graduates and etc. The results of the survey of the stakeholders are analysed and used for the development of the program. The rezults are discussed with the members of the program committee and appropriate changes are made if nessesary. The teaching and research performance of the personnel is monitored through the systematic evaluation of personnel activites. The quality assurance service also evaluates the examination processes and other services provided by the University. The quality assurance service organises regular evaluations of the staff implementing educational programs, with the involvement of students and university administrative staff. At the end of each semester students evaluate the courses and lecturers through questionnaires. The progress of the educational process is evaluated through satisfaction surveys anbd if neccecary the issues are sent to the relevant structural units for response.
