

ACHIEVEMENTS OF THE EDUCATIONAL PROGRAMMES

Quality of the delivered educational programmes

The main resource providing high quality of training is a highly-qualified teaching staff with academic degrees and titles. The study process of educational programmes "Economics and Management" is provided by 70 teachers with basic education corresponding to the profile of the disciplines; over 85% of teachers have an academic degree of a Doctor or a Candidate of Science.

Employability of graduates

Graduates of the Faculty of Economics are in-demand at the labour market of the Chuvash Republic and other regions of RF. The employment rate of graduates of the Faculty of Economics is over 80. The University carries out constant work on expansion of its partner networks who are interested in a mutually beneficial cooperation in the sphere of training of highly-qualified staff. The University concluded agreements with over 50 enterprises and institutions of the Chuvash Republic.

Provision of up-to-date education

Updating of the content of educational programmes is ensured by a regular renew of curricula and working programmes, by introduction in the educational process of modern technologies, as well as by attraction of qualified specialists to the study process.

The Faculty of Economics constantly develops connections with a professional community. The Board of Trustees of the Faculty is founded and successfully operates. Branches of departments are opened on the base of a number of organizations of the Chuvash Republic.

Scientific activity

In 2011-2015 teachers and students of the Faculty of Economics took part in 45 international and all-Russian conferences with an international participation. Over 36 monographs, 13 books, 51 study guides, 142 teaching aids, 13 collections of scientific papers, 245 articles and 15 articles in international editions were published during this period.

Material and technical base

The Faculty of Economics has material and technical base necessary for all types of disciplinary and interdisciplinary training, laboratory, practical and research work of students.

The material and technical base includes classrooms equipped with modern interactive and projection equipment, scientific laboratory, library, computer classrooms, sport hall, canteen and hostels.

Academic mobility of students

To provide an opportunity to give lessons in a foreign language the Faculty of Economics conducted free intensive training of English and German languages for the teaching staff during 2 years. Additional language training of students is conducted in the Educational linguistic centre and Adult education centre of the University.

In 2012 some students undertook semestrial training in Vilnius University (Lithuania) in the frameworks of international programme Erasmus.

Students from Turkmenistan, Angola, Bangladesh, Equatorial Guinea and Syria study at the Faculty of Economics.

Mobility programmes of students with higher education institutions of Slovakia, Hungary, China, Kazakhstan and Belorussia are at present at approval stage.

International projects

The University maintains close multilateral scientific cooperation with foreign HEIs and research centers. The University performs such types of international cooperation as scientific internships, conferences and seminars, joint scientific projects, exchanges of students and teachers, scientific publications, methodological materials, curricula and programmes of course units. Teachers and students of the Faculty of Economics took part in different international projects and internships in Belorussia, China and Kyrgyzstan for the last 2 years.

At present the University has many foreign partners which allow maintaining different types of international cooperation. The University concluded 56 agreements with higher education institutions of Armenia, Belorussia, Bulgaria, Brazil, Italy, Kazakhstan, Kyrgyzstan, China, Lithuania, Norway, Poland, Slovakia, USA, Tajikistan, Uzbekistan, Germany and Czech Republic.

COMPLIANCE OF THE EXTERNAL REVIEW OUTCOMES WITH THE NCPA'S STANDARDS

STANDARD 1. Policy (mission, vision) and procedures for quality assurance

Compliance with the standard: full compliance

Good practice

Tasks and objectives of educational programmes are documented, correspond to the mission of the University and are corrected with account of survey results, questionnaires and recommendations of all stakeholders.

Questionnaire of students is held annually. Assessment of conditions of education, psychic atmosphere, level of education satisfaction is given during such surveys.

Opinions of representatives of professional community are taken into account in defining objectives and development strategy of educational programmes. For these purposes the educational programmes are presented to the leading enterprises and organizations of the region for review.

Teachers and students take active part in internal quality assurance procedures as well.

- It is necessary to create conditions for promoting mobility of students and teachers.
- It is recommended to attract extra budgetary funds for implementation of educational and scientific projects as well as development of educational infrastructure.
- It is important to identify competitive advantages of educational programmes, provide creation and advancement of a positive image of educational programmes.
- It is required to develop e-technologies of education as one of strategic priorities of achievement of objectives of the development programme.

STANDARD 2. Approval, monitoring and periodic review of study programmes

Compliance with the standard: substantial compliance

Good practice

Review of curricula and programmes of course units is held regularly. Integrated curricula containing needs of students and employers are also developed.

Opinions of students are taken into account while choosing the disciplines of an elective part of curricula.

Rectorial internet exam is held annually. Based on the results of this exam effectiveness analysis of implementation of the educational programme is conducted.

Internal and external assessment of implementation of the educational programme is held annually as well. Results of internal and external assessment are published in a free access at the official website of the University. Assessment of programmes is conducted by part-time employers and provides internal vision of the programme, its strong and weak sides.

Areas for improvement:

 It is recommended to improve information system development of the educational process in order to improve monitoring procedures of educational programmes.

STANDARD 3. Assessment of student learning outcomes / competencies

Compliance with the standard: **substantial compliance** Good practice

Assessment of knowledge and competences of students is carried out through interim, semester and final attestations. Funds of assessment tools are approved in all the disciplines. Since 2012 the point-rating system of students' assessment is implemented.

Research projects of students of the Faculty of Economics participate annually in grant competitions and become winners. Student mass media timely informing about achievements of students and their participation in research operate at the faculty.

The University closely cooperates with foreign HEIs and research centers and performs exchanges of students.

The Faculty of Economics provides assistance in graduates' employment. Meetings with the heads of leading organizations of the Republic are conducted on a regular basis. Besides the centre of promotion of graduates' employment functions at the level of the University. Demand for graduates of educational programmes is observed. Different social networks are used for employment monitoring of graduates.

- It is necessary to implement new forms of participation of students in research work.
- It is recommended to improve the technology of analysis of data collection (feedback system) with students about the level of satisfaction of the disciplines, teachers and programme.
- In order to implement the development strategy of educational organization it is recommended to inform students about the rules and possibilities of international mobility.

STANDARD 4. Quality assurance of teaching staff

Compliance with the standard: substantial compliance

Good practice

Educational programmes are delivered by teachers with high qualification, academic degrees and titles. The staff of the Faculty of Economics is young enough.

Results of research work, including the list of publications is annually posted at the official website of the Faculty of Economics. There exists an incentive system of teachers for publications in top-rated journals.

The system of material incentives is developed and documented as an effective contract. The University encourages teachers' motivation to self-improvement by using such instruments as competitions for honorary titles: "Scientist of the Year", "Professor of the Year", "Associate Professor of the Year", "Senior Teacher of the Year" and "Assistant of the Year".

The University concluded 20 agreements with higher education institutions situated in Europe and Asia. Teachers of the Faculty of Economics took part in 45 international conferences and all-Russian conferences with international participation in 2011-2015.

There exists a system of qualification improvement. Teachers have an opportunity to choose a programme and an organization from leading Russian educational institutions.

- It is recommended to develop net programmes with partner HEIs in order to attract a large number of Doctors of Science.
- It is necessary to attract foreign teachers to the study process.
- It is required to create conditions for studying foreign languages through stimulation for getting a language certificate or a possibility to publish articles in a rating edition.
- It is recommended to develop a motivation policy of teachers for thesis defense abroad.

STANDARD 5. Learning resources and student support

Compliance with the standard: substantial compliance

Good practice

Material and technical base includes specialized classrooms, research laboratory, language room, computer classrooms and libraries. There are branches of departments functioning on the base of leading enterprises of the Chuvash Republic.

Students are provided with necessary literature corresponding to the requirements of the programme. Every student has an access to modern e-library systems.

There is a well-developed social infrastructure (sport complex, student medical center, University medical center, health centre, sanitary preventative clinic and others).

There is a feedback system at all levels of administration: rector, dean and head of department.

- It is necessary to update technological base of anti plagiarism which means development of the list of used databases.
- It is recommended to provide all teachers with working places and teach them how to use modern citation and index systems.

STANDARD 6. Information system providing effective implementation of the study programme

Compliance with the standard: substantial compliance

Good practice

The University uses a system of electronic document flow for an effective management. The system collects and handles data about students. All data are accumulated in a unified electronic base with information about individual plans of the teaching staff, standards, academic calendar and curricula.

The study process is automated to a sufficient level and makes it possible to distribute academic load at the department, form reports, carry out individual plans; simulate the data system about students, pack and print academic and exam records.

The University uses the system "Applicant" to optimize the work of admission board, synchronized with technical secretaries of faculties.

The University has its own automated system for employment assistance.

Some teachers develop electronic courses on the base of a distance education system Moodle.

- In order to improve a current mechanism of information collection, analysis and distribution, necessary for effective management of educational programme, it is recommended to develop the system of e-record book.
- It is necessary to attract more active graduates into associations in order to rationalize data collection about advancement and employability of graduates at the labour market.

STANDARD 7. Public information

Compliance with the standard: **full compliance**

Good practice

Information about the content of the educational programme, expected learning outcomes, given qualifications, level of teaching, types of education and assessment, academic opportunities of students is presented at the official website of the Faculty of Economics.

Public information is carried out through social networks, journal "We are economists" and career-quidance work.


Information is available for all stakeholders: applicants and their parents, students, teachers and employers.

The University conducts active work on network expansion of its partners and cooperates with potential employers in graduates' employment through the Employment center.

- It is recommended to create a motivation system of the teaching staff.

CONCLUSION OF THE EXTERNAL REVIEW PANEL

Based on the self-evaluation report analysis, documents and data submitted and interviews the External Review Panel came to the conclusion that educational programmes "Economics" (38.03.01, 38.04.01), "Management" (38.03.02, 38.04.02), "Finance and Credit" (38.04.08) delivered by the Federal State Budgetary Educational Institution of Higher Professional Education "I. N. Ulianov Chuvash State University" substantially comply with the standards and criteria of public accreditation of the National Centre for Public Accreditation.

The External Review Panel recommends the National Accreditation Board to accredit the educational programmes "Economics" (38.03.01, 38.04.01), "Management" (38.03.02, 38.04.02), "Finance and Credit" (38.04.08) for the period of 6 years.
