



ACHIEVEMENTS OF THE EDUCATIONAL PROGRAMME

Quality of implementing the educational programme

Educational programmes, which allow selection of applicants with high passing scores are considered as the basis of high quality of educational programmes delivery. The high qualification level of teachers is maintained by further vocational educational training and retraining programmes, including the programme "Quality assurance of education and modern educational technologies", participation in the conferences and training-classes, research activity for joint projects in the leading research institutions, universities and companies of Europe and the USA. A competition of methodological developments on an annual basis, which allows improving the methodological support of the educational process, is held. The necessary term for recognition of the quality of training of specialists is the consideration of the opinion of employers. Continuous internal monitoring of the quality of the implementation of educational programs, including practical tasks, allowing to assess the level of training of the students, in addition, the students participate in competitions of various levels.

Provision of up-to-date education

Current programme content is delivered due to fluent response to labour market needs, consideration of scientific achievements and training practice and employers' opinion during annual updating of educational programmes. Student questionnaire allows revealing dimensions of educational programmes updating. Cooperation with employers while delivering high-level organization and holding student vocational internship is one of the key tool for updating content of education. Annual carrying out of scientific student Conferences allows delivering urgent researches in the framework of the modules, deepening knowledge. Elaboration of the modern educational programmes is delivered with due consideration of the requirements of professional standards.

Teaching staff

As of 01.05.2016 the teaching staff of the Institute of Economics and Entrepreneurship consists of 374 people including part-time workers. 48 Doctors of Science, Professors (12.9 %), 235 Ph.D.'s (75.6 %), 91 teachers without degrees (24.3 %). As of 30.06.2016 the teaching staff of the main departments delivered educational process of the cluster of educational programmes "Economics" (38.03.01), "Economics" (38.04.01) consists of 139 teachers , including 22 Doctors of Science (among them 16 Professors), 83 Ph.D.'s (59.7%) (among them 72 Associate Professors). The total number of teachers with degrees is 75.5%.

Independent assessment of student learning outcomes

UNN ranks among Top-50 universities (25th place) in "Economics and Management" according to Rating Agency RAEX (expert RA). The university took part in independent assessment of knowledge of the HEI students which was held in the framework of interim assessment during examination period of the 2015/2016 academic year by module Long-termed financial policy, 38.03.01 Economics. An average expert mark and average university mark is 4.50.

Learning Resources

Availability of educational sources for the students is achieved due to publishing them on the university web-site as well as publishing in electronic resources of UNN Fundamental Library.

Electronic courses for teachers of Institute of Economics and Entrepreneurship preparing Bachelor's degree students and Master's degree students of the cluster "Economics" (74 modules); educational and methodological sources for teachers of Institute of Economics and Entrepreneurship (97 sources); educational sources of department, published on the web-site of the Institute.

The Collection of traditional books and theses contains over 1500k items, 680k titles and is universal in terms of content and variety.

Electronic collection includes 25000 records. Corporate electronic collection of books is available on-line in the libraries.

Research activity

During the period from 2014 to 2015, one thesis for the degree of Doctor of Sciences and 11 theses for the degree of Ph.D. were defended at Institute of Economics and Entrepreneurship including theses under the supervision of leading faculty members of the Institute.

Institute of Economics and Entrepreneurship is proactively involved in UNN research initiatives.

At the moment, 47.2% of instructors have the h-index of \leq 2.

Students of the cluster of degree programs "Economics" are actively engaged in research work. Their works have been published in various journals, including those recommended by the Higher Attestation Commission.

Academic mobility of students

UNN supports student academic achievements in different ways.

The students of the Institute have an opportunity to enroll in the additional educational programme "Translator in the Sphere of Professional Communication", to take courses of English and Italian. Students can also take a special test and receive a language certificate confirming their English level.

The Institute of Economics and Entrepreneurship uses a grade-rating system of academic performance assessment of the students.

In 2011 – 2016, graduates of the cluster of degree programmes "Economics" received 19% of the total number of Diploma Supplements issued at UNN.

Employability of graduates

The Career Center is available at UNN.

The analysis of employability of graduates shows that about 97-98 % of graduates were employed. Among them 80 % were employed by the profile of the training obtained at UNN.

International projects

Over 100 universities from 40 countries are UNN's partners in the field of education. As a part of consortia of European universities, UNN is currently implementing a project within the European Commission's Tempus programme 544202-TEMPUS-1-2013-1-AT-TEMPUS-JPHES (BUSEEG-RU-UA) "Developing Intra- and Entrepreneurial Competences through Entrepreneurship Education and Start-up Consultancy".

The Institute of Economics and Entrepreneurship trains a great number of international students.

In 2014, UNN launched an "International Economics" degree programme taught in English within the cluster "Economics". Teachers, students, post-graduates have opportunity to undergo training, internship and further vocational educational programmes in the framework of the international projects and grant-system.

GOOD PRACTICE

Standard 1. Policy (goals, development strategy) and quality assurance procedures of a study programme

The internal quality system is available in the UNN. The mission for each cluster of the programmes in "Economics" has been clearly defined in accordance with the UNN Mission. Each degree programme within the cluster "Economics" has a defined set of goals and objectives, as well as developed and approved documents regulating the content, organization and quality control of the educational process.

The UNN is one of Russia's leading universities and ranks among the top 800 universities of the world according to the QS World University Rankings. The university is also a participant of the programme to enhance the competitiveness of Russian universities among the world's leading research and education centers ("5-100-2020").

Standard 2. Design and approval of programmes

The information about the programme educational objectives and the expected learning outcomes is available in the documents. These documents are published on the official website of the UNN. They correspond to the mission, goals and objectives of the educational organization.

The changes in the demands of the labor market are analyzed through updating the degree programme cluster in compliance with the FSES HE and professional standards. New job opportunities arise from updating the stock of companies offering internships to the students, from creating favorable environment for the students' personal growth, progress and development while learning at the educational program including further educational programmes.

Standard 3. Student-centred learning, teaching and assessment

The system of forming an individual learning path is available in the Institute of Economics and Entrepreneurship.

The documents regulating learning outcomes/competencies assessment, are available at the UNN (for example, the Regulation on the Monitoring of the Current Performance and the Interim Assessment).

Students have access to the data about the programmes, curricula, abstracts of the modules, internships, methodological and other documents related to the EP, the procedures of assessing learning outcomes/competencies; the feedback system is available as well as the system of responding to students' complaints.

The programmes aimed at academic mobility with European universities are actively enhanced.

The regulation on the score-ranking system of the students' achievements, which includes formation of the conditions for well-being

for a continuous development, personal growth and progress during their training, has been elaborated at the University.

Standard 4. Student admission, support of academic achievements and graduation

The Institute of Economics and Entrepreneurship IEP conducts systematic work to support academic achievements of students.

The system of vocational guidance aimed at preparing and selecting applicants is successfully implemented at the Institute. The "Open days" are organized on a regular basis.

Graduates of the UNN in the field of Economics have the opportunity

to receive the European Diploma Supplement.

The Career Center at the UNN has been opened for collecting information from employers about vacancies; preparation of students for active participation in the labor market; making proposals on improving the training process and elaboration of the new EP.

Standard 5. Teaching staff

Highly qualified teachers with specialized education, academic degrees and academic positions by the profile and work experience deliver the educational programmes of the cluster "Economics". The teachers take an active part in education and research activity, which can be proved by the publications of educational and methodological materials, monographs, scientific articles both in Russian and foreign periodicals.

The teachers have an opportunity to participate in the joint international projects, foreign internships, programmes of academic mobility.

UNN won 7 projects for involvement the leading teachers of the Russian Higher professional educational institutions.

Standard 6. Learning resources and student support

The material and technical resources of the educational programmes of the cluster "Economics" are available in sufficient number and comply with the syllabi of the modules. The students have a free access to electronic library stock, the educational programmes are provided with a sufficient number of paper references.

The methodological guidance is available at an electronic resource.

Standard 7. Collection, analysis and use of information for managing the study programme

An effective system of gathering information about the students' achievements (Department for Educational) and Social activities, coordination for Youth Policy and Pedagogical Activity, UNN) is available at the Institute. Availability of the wall of honour with the information about the best students in the educational programmes.

The document turnover system has been implemented at the University. All the information resources have been united in a united information system.

Standard 8. Public information

The Department for Public Relations and Internet Communication of the University has active cooperation with the regional mass media.

The university periodical is published on a regular basis. Social websites are actively used for informing all stakeholders.

The teaching staff actively cooperate with different professional associations including foreign ones.

Standard 9. On-going monitoring and periodic review of programmes

The representatives of professional community are involved in the procedures of review and revision of the educational programmes.

Availability of the documented monitoring procedures, regular evaluation and review of the educational programmes, established by the local Regulations.

The feedback system from all the stakeholders of the educational programmes is developed.

Carrying out the regular-based monitoring procedures.

Standard 10. Cyclical external quality assurance of study programmes

The external quality assessment of the educational programmes is held at the University on a regular basis.


The representatives of professional community (the Ministry of Economy of the Nizhny Novgorod Region, Nizegorodskaya ASSOCIATION of industrialists and entrepreneurs) of the Nizhny Novgorod Region are involved in the procedure of External Review.

RECOMMENDATIONS

- 1. Preparation of a road map describing specific ways and stages to implement the policy of quality assurance at the level of IEE.
- 2. To form an Internal Panel at IEE for implementation and improvement of the quality assurance policy with the participation of all the stakeholders.
- 3. To improve the mechanisms for effective interaction of all the stakeholders (students, employers graduates) in the development and implementation of the quality assurance policy, elaboration and review of the educational programmes.
- 4. To widen the methods of involving the employers to improve the quality assurance system at all stages of the elaboration and implementation of the cluster of the educational programmes.
- 5. To involve employers more widely in the delivery of the elective courses, reflecting the profile (orientation) of the programme, to reviewing the syllabi of the disciplines, elaborated by the university teachers.
- 6. To increase the percentage of graduate qualification works prepared at the official request of employers.
- 7. To improve the approaches to the formation of individual learning paths.
- 8. To improve the feedback system about the ways used to evaluate and adjust teaching methods.
- 9. To expand the participation of undergraduate students in academic mobility programmes.
- 10. To actively implement the programmes of training in partner universities, with the possibility of recognizing the training period and transfer credits on condition that the interim assessment at the partner-university has been successfully passed.
- 11. To consider the possibility of elaboration and implementation of the master's programmes in English for the export of educational services.
- 12. To consider the possibility of expanding the list of taught foreign languages in the framework of the professional educational programmes taking into account the international educational student exchange programmes.
- 13. To consider the possibility of including a second foreign language at the choice of the students as an elective part of the curricula of the educational programmes.
- 14. To increase the international programmes of academic mobility including ERASMUS programmes for teachers.

- 15. To develop a system of improving competences in the English language for teachers.
- 16. To develop a system of forming competences in the field of econometric and mathematical methods for studying economic processes and phenomena.
- 17. To strengthen the motivation for publishing activity of teachers.
- 18. To expand the use of innovative methods of teaching and advanced technologies in the educational process.
- 19. To expand the participation of students and teachers in the procedures of collecting, monitoring and analysis of information on the management of the educational programme.
- 20. To ensure the transparency in informing about the employment opportunities of graduates.
- 21. To improve the section of the University website containing information on employability and labour market demands of the programmes under accreditation.
- 22. To formalize the procedure of involving professional communities in the procedures of monitoring and periodic review of the study programmes in Economics.
- 23. To enhance the use of distant (electronic) technologies in the educational environment.
- 24. To facilitate the work on involvement of representatives of professional communities in the quality evaluation of the study programmes not only at the regional but also at the federal and international levels.
- 25. To expand the number of further educational programmes for students based on the marketing research.
- 26. To consider an opportunity of increasing the proportion of work placement time in major professional study programmes.

CONCLUSION OF THE EXTERNAL REVIEW PANEL
