

**EXECUTIVE SUMMARY OF A DECISION OF THE ACCREDITATION COUNCIL**  
**on the results of an evaluation conducted under a *programme accreditation* procedure for**  
professional field *1.1. Theory and Management of Education*, area of higher education 1.  
Educational Sciences, at Sofia University “St. Kliment Ohridski”

The procedure was opened at a session of the Accreditation Council on 25 January 2024 at the request of the higher education institution. The Expert Group, endorsed by the Accreditation Council on 25 April 2024, visited the evaluated institution in the period 17–18 June 2024 and inspected the submitted procedure documentation.

At a meeting held on 9 September 2024, the Standing Committee on Educational Sciences and Social Activities adopted the report of the Expert Group and, based on it, prepared a report on the results of the completed programme accreditation. The report of the Standing Committee contains **findings and assessments on the compliance of the presented evidence with the criteria system for the implemented procedure, in accordance with the Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG) – part 1 (1-10), and within the meaning of Art. 78, para. 3 of the HEA.**

On **13 February 2025** the Accreditation Council endorsed the report of the Standing Committee pursuant to Art. 81, para. 3 of the HEA, and took a vote using the ten-point grading system provided for in Art. 78, para. 6 of the HEA, and based on the Rules for assessment and voting in procedures for evaluation, accreditation and post-accreditation control, adopted by NEAA.

After summarizing the results of the vote, the Accreditation Council took the following **DECISION:**

**1. Awards programme accreditation to professional field *1.1. Theory and Management of Education*, area of higher education 1. Educational Sciences, at Sofia University “St. Kliment Ohridski”, based on an overall grade of 9.22 (nine point twenty-two), for educational and qualification degree “Master” in:**

- “Educational Management” – full-time and part-time forms of study, in Bulgarian and in English;
- “Management of Services and Organizations for Non-Formal Education” – part-time form of study.

**2. The term of validity of the accreditation is until the next programme accreditation according to Art. 81, para. 2 of the HEA, and the Schedule for Accreditation of Professional Fields.**

**3. Determines the total capacity of the professional field at 144 students and doctoral students.**

The Accreditation Council made the following **recommendations:**

1. Improve the quality and efficiency of administrative services for students as measured by meetings with students.

Deadline: permanent

2. Ensure a balanced distribution of classroom teaching loads among faculty members across the various Master’s programmes.

Deadline: January 2026

3. Increase the number of habilitated staff in PF 1.1. *Theory and Management of Education*.

Deadline: January 2026

4. Increase student participation in Erasmus+ mobility programmes and in research projects.

Deadline: permanent
