







ACHIEVEMENTS OF THE EDUCATIONAL PROGRAMMES

Quality of implementing the educational programmes

In 2015 the university obtained state accreditation for all the programmes undergoing the accreditation procedure. The management system of the university quality is certified in accordance with the requirements of ISO 9001:2008. Successful joint accreditation (professional, public and international) was obtained by four educational programmes.

Provision of up-to-date education

Representatives of employers are involved as experts in the programme development in Sociology. The educational programmes undergo an expert review in the Academic Process Control Department and are also reviewed and assessed by employers.

The content of the educational programmes is annually updated in accordance with any changes in the legislation. The main task of updating is achieving flexible response to labor market requirements, as well as taking into account new scientific achievements and trends in education. Adjustment procedures have to rely on the requirements of legal acts, recommendations of employers and opinions of students.

Teaching staff

The total number of teachers involved in implementation of the Bachelor's programme of "Sociology" is 39 people; the number is sufficient to carry out the academic tasks and ensures the quality of education. The percentage of full-time teachers is 94,9%. The percentage of teachers with academic degrees and titles is 79,5%.

The total number of teachers involved in the Master's degree programme of "Sociology" is 14 people. 100% of them have academic degrees, among them 28,6 % are Doctors of Sciences.

Independent assessment of student learning outcomes

Since 2015 the university has taken part on a regular basis in the project "Federal Internet Exam in Professional Education".

Employability of graduates

The percentage of employed Bachelor degree graduates in "Sociology" who continued education for Master's degree in "Sociology" in 2015 was 87%, in 2016 – 83%. The percentage of employed graduates of Master's degree in "Sociology" in 2015 was 78%, in 2016 – 81%.

Learning resources

Development of electronic resources in FEFU's Library provides for the completeness, relevance and availability of information on the results of laboratory, educational and research activity of the University. The on-

line catalogue of FFEU Library contains over 710 000 bibliographic records. In addition to the funds of the Library, it contains information from external on-line catalogues, such as Lan, Student Consultant, IPRbooks, INFRA-M.

Research activity

The teachers of the Department of Social Sciences are actively involved in research activities. In recent five years 9 monographs, 109 articles have been published in peer-reviewed journals. The teachers actively take part in international, Russian and regional conferences.

Academic mobility of students

Regular and consistent work in the student involvement in research activity is organized at the Department. The students take an active part in the conferences of different levels: regional, national and International.

The students participate in the scientific event "The Prospects of Integration and International Cooperation in East Asia: Russian-Taiwanese Symposium".

International projects

The teachers take part in the scientific event "The Prospects of Integration and International Cooperation in East Asia: Russian-Taiwanese Symposium". The international master's programme "Sociology of Economics and Management" in English, delivered jointly with the Chinese partner universities is being developed.

GOOD PRACTICE

Standard 1. Policy (goals, development strategy) and quality assurance procedures of a study programme

Availability of the internal Documented Quality Assurance System.

The focus of educational programmes on the needs of the regional labor market in accordance with the primary objective of the University: to become a leader in the educational process in the Far East of the Russian Federation, to form a research and education cluster, which could compete with the leading universities of Asia-Pacific Countries.

Participation of all the structural subdivisions in the development and implementation of the quality policy, participation of managers, teachers and students in the process at the level of educational programmes.

Formation of the students' and teachers' incentive system for participation in a wide range of research to form specific professional competencies.

Standard 2. Design and approval of programmes

The goals, objectives and strategies of the educational programmes correspond to the FEFU's mission.

The requirements of the professional standard "Specialist in the organization and carrying out sociological and market research" are taken into consideration.

Availability of the data collecting system to assess satisfaction and expectations of students and teachers.

Standard 3. Student-centered learning, teaching and assessment

Availability of conditions for implementing individual learning paths with an opportunity to choose disciplines, work placement, as well as training in virtual learning environment and online courses.

Since September 2016 the implementation of a new educational model for the preparation of bachelors "Education 2.0" and the introduction of Major and Minor has been in progress.

Wide involvement of students, including Bachelor students, in research activities.

A high degree of awareness of students about the assessment procedures.

The mechanism of assessing expected learning outcomes generally complies with the Dublin descriptors.

The existence of an effective appeals system, complaints of students, and their objective and public consideration.

Standard 4. Student admission, support of academic achievements and graduation

Availability of a comprehensive information system, aimed at student recruitment during career guidance.

Availability of necessary conditions for the recruitment to Master's programmes of those students who were awarded a bachelor degree in a different institution.

FEFU graduates can obtain the European Diploma Supplement.

Availability of a financial support system for students' participation in research conferences, internships, seminars, meetings, summer schools.

Agreements with large research institutions, organizations, business-companies of the USA, Germany, Spain, Japan, Republic of Korea, People's Republic of China on participating in student exchange programmes.

Standard 5. Teaching staff

High percentage of teachers with academic degrees and titles (the total number involved in the implementation of the Bachelor's degree programme – 76,9%, in the Master's degree programme - 85,7 %).

High level of publication activity of the teachers.

Wide use of interactive methods of teaching, discussions, round-table conferences, seminars.

An efficient incentive system of the teachers' activity.

An efficient system of human resource development.

Standard 6. Learning resources and student support

Providing the educational programme with sufficient material resources and facilities in accordance with the requirements of the programme (equipment, computers, classrooms, laboratories).

The sufficient library stock with more than 2 mln copies of research, education, methodological, fiction in Russian and foreign languages.

Availability of introduction programmes for special needs students. An efficient feedback system.

Standard 7. Collection, analysis and use of information for managing the study programme

Availability of a united information network "Electronic University", which includes publicly available sources and personal profiles.

The formation of the Student Council on the basis of the School of Humanities. The members of Student Council take part in designing and delivery of the programmes, aimed at the improvement of the educational process.

Efficient participation of students and teachers in data collecting for the educational programme management

Standard 8. Public information

The information about the quality of educational programmes, delivered by the University, at the official web-site of the University is complete and relevant.

Active use of different social sites for the information support of stakeholders and distribution of newsletters in the foreign mass media databases to attract foreign applicants.

Standard 9. On-going monitoring and periodic review of programmes

Regular monitoring and periodic assessments of educational programmes quality.

Availability of the feedback system from the stakeholders of the educational process.

Stable and long-term cooperation with employers.

State accreditation of the main educational programmes under review.


Successful participation in the procedures of international public accreditation.

RECOMMENDATIONS

- 1. To take measures for involving all stakeholders in the working group for discussing and correcting the quality policy and objectives.
- 2. To involve students and internal stakeholders (employers, professional communities) in the development of the educational programmes and quality assurance procedures.
- 3. To develop a programme aimed at employability of graduates of educational programmes.
- 4. To expand and develop a tool aimed at forming individual learning paths.
- 5. To actively use internal assessment tools, including student feedback, containing data on problems in the educational process and proposals for improvement.
- 6. To improve the quality and methods of student recruitment to the educational programme by publishing clearly defined conditions, objectives and outcomes of the meetings, people responsible for the recruitment as well as targeted indicators including the use of "road maps".
- 7. To introduce the programme aimed at the student and teacher mobility.
- 8. To develop a programme of vocational training for teachers in the professional programmes (Sociology) in the leading Russian and foreign universities.
- 9. To develop a system for involving the leading Russian and foreign scientists in the educational and research processes.
- 10. To implement the feedback system for the key stakeholders through the monitoring system of internal (graduates) and external (labor market) needs for regular review of the educational programmes and strengthening the role of the programme managers in job-placement of graduates.
- 11. To involve practice of employer-sponsored education through agreements with the key organizations-employers for job-placement of the best graduates of the educational programme.
- 12. To publish objective information on job placement and demand for graduates of the educational programmes on an annual basis.
